2. **The candidate must satisfy him/herself of the eligibility criteria before applying.** The above vacancies are subject to change and the Institute reserves the right whether or not to fill up any post. No appeal will be entertained or accepted. It would not be obligatory on the part of the Institute to call for Interview every candidate who possesses the essential qualification and no representation in this regard will be entertained from any candidate.
3. The effective date for reckoning the requisite qualification and experience and the upper age limit is **10th October, 2021.**
